

George Alexander Foundation Scholarship

Terms and Conditions

As a successful recipient of the **George Alexander Foundation Scholarship** at Murdoch University, I agree to the following terms and conditions and understand that it is my responsibility to adhere to the following conditions:

1. I must relocate from a regional or remote area to Perth to commence or continue my studies at Murdoch University, as this scholarship is intended to support students who incur relocation-related costs.
2. I must remain enrolled full-time in an undergraduate program at Murdoch University for the full duration of my scholarship. For domestic students 9 credit points or more is considered full-time.
3. I must strive to maintain a Credit average each Semester for the term of the scholarship. If I fail to meet this requirement, my scholarship may be terminated unless there are exceptional circumstances.
4. I agree to release GPA results to the Foundation on a semester-by-semester basis throughout the term of my award.
5. I agree to promote the value of the Scholarship Program both within and outside the University.
6. I agree to participate in a network of George Alexander Foundation Scholars, with a focus on academic opportunities and community service, as appropriate.
7. I may not transfer The George Alexander Foundation Scholarship to study at another institution.
8. I may hold The George Alexander Foundation Scholarship in addition to another institution scholarship, however this will be at the discretion of the University in accordance with the University Scholarship Policy, and other relevant policies, as may be amended and replaced from time to time.
9. I must notify the Scholarships Office in writing immediately if I:
 - Wish to transfer to another academic program within the University.
 - Wish to study abroad on a Murdoch University affiliated placement.
 - Seek a retrospective withdrawal from any units I have enrolled in.
 - Choose to defer my studies and/or apply for Approved Leave.
 - Reduce my study load.
10. I understand that I will forfeit the scholarship if I:
 - Terminate my enrolment.
 - Transfer to another institution.
 - Transfer from full-time to part-time study (unless I have been granted an exemption by the Scholarships Office).
 - Do not maintain satisfactory academic progress (Credit average each semester).
 - Fail to provide up to date contact and/or financial details to the Scholarships Office when requested.
11. I must provide an annual written report to the University outlining how I have performed during the year and how the scholarship funds have been expended.

11. I must seek independent advice from the relevant authorities on the effect, if any, that the scholarship may have on my eligibility for income support or any tax implications.
12. I agree and acknowledge that changes in my enrolment may make me ineligible to receive scholarship payments. For scholarships that continue for more than one year, in the case that I am deemed ineligible I may be placed on a breached status of six months without payment. This status would provide me with the opportunity to improve my grades or reduce my study load, to then be considered for payments in the following semester. This opportunity would occur only once for the duration of the scholarship and is at the discretion of the Scholarships Office and the donor.
13. I understand that continuing to receive payments that I am ineligible for will result in action taken by the university. In the case of receiving ineligible funds, I will be required to repay all ineligible payments to the Scholarships Office within a 3-month period.
14. I understand and agree that the information I provide in my scholarship application and any supporting documentation may be shared with the donor organisation, Murdoch staff members, and appointed panel representatives for the purposes of awarding this scholarship.
