

# “Open Day Registration 2026” Competition

## Terms and Conditions

### Open Day Registration 2026 Competition

1. Open Day Registration 2026 Competition (**Competition**) is a competition run by Murdoch University of 90 South Street, Murdoch, Western Australia, 6150.
2. The Competition commences at 10:00 Australian Western Standard Time (**AWST**) on Monday 19 January 2026.
3. The closing time for entering the Competition is 08:00 AWST on Thursday 26 March 2026.
4. Bose, Google and BlockBlueLight are not participants in or sponsors of this promotion.
5. By entering the Competition, entrants agree to abide by these Terms and Conditions.

### The Competition

6. To enter the Competition, participants are required to register to the Open Day 2026 event on the Murdoch University website (<https://www.murdoch.edu.au/study/open-day/sign-up>) between 10:00 AWST on Monday 19 January 2026 and 08:00 AWST on Thursday 26 March 2026.
7. All entries must be received no later than 08:00 AWST on Thursday 26 March 2026.
8. Late entries will not be accepted and Murdoch University is not liable for late, lost or misdirected entries.
9. Participant must reside in the state of Western Australia.
10. Entrants may only enter the Competition once.
11. Murdoch University students and employees and their immediate family members are not eligible to enter the Competition.
12. Instructions on how to enter and other details contained within promotional advertisements for this Competition form part of the conditions of entry.
13. Entry to the Competition is free.
14. Entrants will be responsible for all costs associated with entering the Competition.
15. By entering the Competition, the entrant agrees that they are over the age of 18 years, or if under the age of 18 years, have their parent's or legal guardian's consent to enter the Competition.

35. Murdoch University is not responsible in any manner whatsoever for any problems or any financial costs incurred, or any combination thereof, including any injury or damage to entrants or any other persons related to or resulting from participation in this Competition.
